#### A MESSAGE FROM THE CHILDREN'S COTTAGE SOCIETY

The Children's Cottage Society has been committed to providing assistance to those in need in Calgary and the surrounding area for over 24 years. The recent global economic upheaval has made our programs a growing necessity for vulnerable children and their families. While we worried there could be potential reductions in funding, we were fortunate and thankful that our funders, donors, and volunteers continued to support us so we could ensure children and families received the services and support they needed.

Providing children with safe shelter during a family crisis is important work; teaching and supporting their parents is imperative, and bringing the community together to ensure excellence is what makes serving those in need sustainable.

This past year, we focused on how we could improve our outcomes by enhancing our models of service delivery. Practice methods and job descriptions were reviewed in each program area to improve the delivery of our services. Although change is never easy, we are proud to report that staff rose to the occasion implementing new methods of practice. We look forward to seeing the benefit to children and their parents over the next year.

The execution of a new communication strategy saw the unveiling of new colours profiled in this report. Our logo was refreshed and maintains the image that we are known for. Sharing information about monthly events and stories is an important focus and now includes an e-newsletter. We still have much to do to complete our current strategy, and are working to obtain funding to communicate what we are and what we do for all Calgarians.

Our board focused on directions for sustainable funding and, to that end, created and launched our Circle of Hope program. The Circle of Hope represents supporters who make a multi-year commitment of \$10,000 or more annually. This investment enables the Society to plan for the achievement of our goals, with the security of financial stability. We welcome our Circle members to meet annually to discuss what their investment has done and to have a dynamic conversation and share ideas for the future directions of our programs.

Where children are involved, like any family, our agenda is not finished. More must be done to deliver care, support and education toward our mission of "safe children in healthy families". We look forward to discussions with our stakeholders that will help us meet the needs of the most vulnerable.

We extend our sincere thanks to our dedicated volunteers, donors, corporate partners, funders and employees who ensure the thousands of children now impacted by our programs continue to receive the care, support and education they require.

Charlie was heavily addicted to drugs and came to Calgary looking for change, from his life on the streets of Vancouver. He had turned to drugs and the streets to numb the pain of an abusive childhood. When he arrived here, he was back on the same path of destruction – until he met Judy.

Judy was a frightened young girl, who also fled an abusive home. Her mother abused her while her father ignored her cries for help. Escaping to the streets seemed like the best alternative – that is when Charlie came into her life.

Shortly after meeting, Judy became pregnant. She and Charlie were excited to turn their lives around and become great parents. She didn't know a lot about parenting, but one thing she was sure of was that they did not want to make the same mistakes their parents had.

Judy's lowest point was not the child abuse she suffered, nor her time on the streets. It was the feeling of helplessness and despair she endured after giving birth to Mya. The anticipated excitement was gone and Judy was diagnosed with post partum depression wanting nothing to do with her daughter.

Charlie struggled to care for Judy and Mya, while trying to stay clean. Charlie needed immediate support that would give him strength to keep he and his family strong and healthy.

Charlie learned of the Children's Cottage Society and showed strength by reaching out for help. Two week old Mya came to the Crisis Nursery when Charlie was at his wits end. Judy needed help and he needed time to take care of her.

Over the next year, Charlie called us when he was overwhelmed. Later he told us, that with no one to turn to, the support we gave his family helped him stay on track with recovery and become a good husband and father.

Charlie, Judy, and Mya have more challenges ahead of them. They've had many successes and tell us that with programs like the Children's Cottage they will be able to learn how to be strong and caring parents. For Charlie, being free of drugs for 5 years, seeing Judy get better, and knowing that they can turn to the Cottage for help gives his family hope toward the brightest future for little Mya.

#### PROGRAM HIGHLIGHTS ...

# The Crisis Nursery

Our 12 bed Crisis Nursery provides short term emergency child care for children age newborn to eight during times of family crisis.

#### **2009 Program Statistics:**

- We made a difference in the lives of **1097 children**, from **692 families**, providing **2486 days** of crisis care.
- The average length of stay for a child at the Crisis Nursery was 2.3 days.
- 98% of children were returned to the care of there parents.
- **1043 children** were turned away due to lack of resources.

## We read 1097 bedtime stories.

### We served 3291 nutritious meals.

#### Parent Profile:

- **78%** of parents helped were parenting on their own.
- 87% were living below the poverty line.
- 20% of parents reported having mental health issues.

#### In 2009 we experienced successful outcomes!

- **30%** told us that using the Crisis Nursery prevented the abuse or neglect of their child(ren).
- **80%** reported that the Children's Cottage services helped them resolve the problem that brought them to us.
- 74.5% felt they will be a better parent after receiving crisis care.

"In times of stress when most people can call on family, friends or a spouse to take care of their children to give them a break, or to simply do things that need to be done, I have no one. The Cottage is my family. Words cannot describe the gratitude I feel for having a place like the Children's Cottage to lean on. To everyone who makes the Cottage possible. # **Healthy Families**

The Healthy Families In-Home Visitors help high risk families with new babies to build on their strengths through regular visits, education and referral services.

#### **2009 Program Statistics and Outcomes**

- **724 children** from **455 families**, received **2,846** home visits.
- 71.3 % of parents reported they have increased knowledge and access to community resources.
- 68.4% of parents reported they have increased knowledge about their child's developmental needs.

"My home visitor had so many tips that enhanced my parenting skills. Sometimes all I needed was a sounding board and she was there for me. I feel that I am more confident as a parent because of this program" - Tatiana

# **Community Respite Programs**

The Community Respite Programs offer parents planned respite care in times of crisis. Respite is provided through in home visitors, coordinated child care placements or volunteer day care offerings.

## 2009 In-Home Infant Respite Program Statistics and Outcomes

- 132 children from 102 families, received 3292 hours of in-home respite.
- 43% of these children were multiples (twins or triplets)
- **55.9%** of parents had high stress levels before receiving respite, decreasing to **19.6%** upon completion.
- 96% of parents agree they are better prepared as a parent after having received these services.

## 2009 Child Care Respite Program Statistics and Outcomes

- 167 children from 104 families accessed 7,778 days of child care.
- 90% of parents indicated that this program had helped their family work on the issues that had brought them to the program.

# 2009 Volunteer Day Homes and Day Cares Program Statistics

Volunteer Day Homes and Day Cares provided 106 days of respite for 100 children from 68 families.

"I can go to the cancer centre knowing my son is safe and well taken care of. It gives me peace and more focus to deal with treatments for the tumor." - Liz

We cuddled 856 babies.

## **Brenda's House**

Our re-housing program operates a shelter owned by the Brenda Strafford Foundation. Using the "housing first" model we aim to support families toward independence and their own housing.

#### **2009 Program Statistics:**

- We served 125 families 368 adults and 181 children.
- The average length of stay for a family at Brenda's House was **39 days.**

# We sheltered 549 people.

#### **Family Profile:**

- **76%** of families earned less than \$15,000 in the year prior to intake.
- 49% of families were parenting on their own.
- 92% of families who stayed with us had children or were expecting.

#### In our first year of operation we achieved positive outcomes!

- 71% of families moved into market housing and are no longer homeless.
- 18.5% went on to second stage housing or to stay with family.
- **43**% of clients utilized referrals to community services such as general counselling or basic needs agencies, to address their issues.

"When I had to take in my four grandchildren because my daughter was unable to care for them, I ended up losing my job and my house. I needed to find somewhere to house us temporarily, until we could work on finding a home. Brenda's House not only took us in, but they worked with me daily through my custody court battle, and my struggle to find affordable housing for me and my four grandchildren. I do not know what I would have done had it not been for the lovely staff and homey environment that made what was such a stressful and difficult time in our lives, a little less painful." - Ruth





#### **VOLUNTEER PROGRAM REPORT**

#### **Crisis Nursery Volunteers**

- 154 volunteers completed 5178 hours of service at the Crisis Nursery.
- 13 Days of Caring Groups including 133 people provided 456 hours of service.

#### **Brenda's House Volunteers**

• **53 volunteers** completed **741 hours** of service at Brenda's House.

#### **Administrative and Event Volunteers**

• **74 volunteers** provided **534 hours** to the Society.

## **Volunteer Day Homes and Day Cares**

37 Day Homes and Day Cares volunteered 106 days of respite free of charge

# 451 people contributed 7651 hours.

# A Message from our Treasurer


For the fiscal year ended March 31, 2010


This past year, the Children's Cottage Society continued to increase its reach to serve more children and families. The success of our programs is attributed to funders and donors. We wish to thank the Calgary and Area Child and Family Services Authority, the City of Calgary Family and Community Support Services, the United Way of Calgary, the Calgary Homeless Foundation, the Brenda Strafford Foundation, and the many donors who have invested in supporting Calgary's vulnerable children and families. We are very grateful for your support and will continue to use your gifts as effectively as possible so that every dollar makes a difference.

In 2009/2010, our revenues reached \$3.4 million, reflecting a 30% increase from the prior year. There was a corresponding increase of 28% in our expenses to \$3.5 million; substantially all of this increase was attributable to staff and operating expenses related to the ongoing operation of Brenda's House, which opened its doors in February 2009. Salaries and benefits for our dedicated team of program staff continue to be our primary expenditure, comprising 78% of total expenses.

We were able to realize the benefits of our strong cash position from previous years to fund the shortfall from operations and, including the investment income realized during the year, we achieved a modest surplus of \$154K (deficit of \$272K in prior year). As we look to the future, we will continue to manage our assets responsibly and conservatively to ensure that the Society is well positioned to provide support to children and families in our community.
